#### ELIGIBILITY CRITERIA

- ❖ Appliances must be purchased in 2017 and must be installed on cooperative's lines.
- ❖ Recycled appliances must be recycled in 2017 and removed from service on cooperative's lines.
- ❖ Rebates are in place through December 31, 2017. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Rebate not to exceed 50% of the cost of appliances. Appliance recycling qualifies for the entire rebate, regardless of the recycling cost.
- ❖ Additional eligibility criteria may apply. Contact cooperative for details.
- ❖ All documentation listed below **must be submitted no later than 3 months after purchase or recycle date.**
  - ✓ This Rebate Form
  - ✓ A copy of your receipt or invoice for each item purchased
  - ✓ ENERGY STAR label for each item purchased if applicable
  - ✓ For recycled appliances, include receipt for each item showing unit is in working order
